## OVERVIEW

Sharon Ben-Shahar Mayer's practice focuses on complex business litigation. ## EXPERIENCE

Successfully quashed service on a national law firm in a case alleging aiding and abetting of securities fraud, breach of fiduciary duty, and professional negligence in connection with a purported billion-dollar Ponzi scheme.

Represents an international law firm and individual attorneys in an action brought by a former client alleging malpractice and breach of fiduciary duty.
